

2017--TOWN OF SHERWOOD, CLARK COUNTY, WI.
AUGUST TOWN BOARD MEETING
August 8, 2017

The Town of Sherwood met Tuesday, August 8, 2017 at 7:30 p.m. at the Sherwood Town Hall. (All board members, clerk & treasurer were notified in the late afternoon to post-poner the town board meeting to 7:30 p.m. because the gravel delivered in our township may take longer than anticipated.) All town board members including clerk & treasurer were present. There were no town electors present.

This meeting notice was published in the Pittsville Record and posted at the town hall, Connies Roadhouse Bar & Grill and at the substation on County Road W. The agenda as follows: call to order, approval of minutes by town board, treasurer's report, town correspondence, reports from officers & committees, public comments upon recognition of the chairman, specific matters for discussion and possible action by the town board in open session: roads, culverts, gravel delivered on roads on 8/8 or 8/9/ 2017, web page, and township picnic, set town board meeting for September 2017 and adjournment.

Chairman Andy Cegielski called the meeting to order. The Pledge of Allegiance was recited. Minutes of the previous were read. A correction--John Ceyress Trucking would haul the gravel for \$10.60 per yard instead of the \$12.60 per yard stated. Therefore a motion by Curtis Anding, seconded by Ken Schwanebeck to accept the minutes with the noted correction. Motion carried. Margaret Schwanebeck gave the treasurer's report. As of July 31, 2017 we have on hand \$40,252.44.

CORRESPONDENCE: Received Clerk-Treasurers Surety Bond bill for \$130.00. This bill will be paid today and the bond detail is for \$30,000, renewable in 2019.

MEETINGS Chairman & Clerk met with Sam Draeger on Wednesday, July 26, 2017 at his office near Marshfield to update us on our new web page on the internet. This meeting took at least 3 hours.

PUBLIC COMMENTS: Chairman Andy will call Adam Cafilish soon to remove the logs from the township cemetery so the fencing can be reinstalled. The chip seal project on Badger Avenue South & Dyer Road should be done in September. Derrick Turzinski of Wausau will be contacting Chairman Andy soon regarding the upgrading (possible painting) of our township grader. He will give an estimate for approval by town board before continuing. After driving on Badger Avenue North on a rainy night, the town board may consider installing a center line or side stripping to see better at night. This is deer country.

ROADS: Someone dumped a pile of tires in the ditch on Sherwood Road West.. Chairman Andy pick them up and will dispose of them soon.

CULVERTS: Received bill from Brad Goetz and John Ceyress Trucking for installing -3- culverts recently. On July 3rd one culvert was installed on Sherwood Road just west of the gun range and on July 31st one culvert was install on Sherwood Road just east of the gun range and the last culverts was installed on August 1st on Colonial Avenue. The total of these three installations are \$3,665.00. John Ceyress Trucking delivered the culverts on June 30th hauled base and clean breaker rock to complete the jobs at a cost of \$3554.10.

GRAVEL: John Ceyress hauled gravel for our township on Tuesday, August 8, 2017.

WEB PAGE: We (supervisors & clerk & treasurer) will be meeting with Chairman Andy soon, so he can show us how to add or delete information on our new web page.

PICNIC: The township picnic is this coming Sunday, August 13, 2017 at 1:00 p.m. and grilling will start at 12 noon. We are to bring a dish-to-pass and our own beverage. All meats, plates, napkins will be furnished by the township.

PAY BILLS: Board approved checks #3650 through #3666. Our next town board meeting will be held Tuesday, September 12, 2017 at 6:00 p.m. at the Sherwood Town Hall. A motion by Andy Cegielski, seconded by Ken Schwanebeck to adjourn. Motion carried. Meeting adjourned. (8:30 p.m.)
