

# 2017--TOWN OF SHERWOOD, CLARK COUNTY, WI. MAY TOWN BOARD MEETING.

May 9, 2017

The Town of Sherwood met Tuesday, May 9, 2017 at 6:00 p.m. at the Sherwood Town Hall. All town board members present including clerk & treasurer.. The were no town residents present.

This meeting notice was published in the Pittsville Record and posted at the town hall, Connie's Roadhouse Bar & Grill, and at the substation on County Road W. The agenda as follows: call to order, approval of last month's minutes by town board, treasurer's report, town correspondence, reports from town officers, public comments upon recognition of the chairman, specific matters for discussion & possible action by town board in open session--roads, culverts, gravel, FEMA, No-Wake Lake ordinance, web page, dust control, brush cutting, pay bill, set town board meeting for June 2017 and adjournment.

Chairman Andy Cegielski called this meeting to order. The Pledge of Allegiance was recited. Minutes of the previous meeting were read. A motion by Curtis Anding, seconded by Ken Schwanebeck to accept the minutes as read. Motion carried. Treasurer Peggi Schwanebeck gave the treasurers report. Payments made to the town for the curbside garbage & recycling service is coming in. We have on hand as of April 30, 2017, \$52,529.32.

**CORRESPONDENCE:** *Received letter* from Superior Sealer, Fall Creek, Wisconsin offering their services for sealing roads.

**MEETINGS:** None attended.

**PUBLIC COMMENTS:** We were informed that Tom Regner wants his land to be in the Pittsville School District instead of the Granton School District. We are scheduled to be first in line for the Veterans Memorial Service held at the cemetery this year. It should be in the Pittsville Record for the time and date. A complaint was made to the town board that a large amount of broken glass was found on the Badger Avenue/County Road Z, corner possibly dumped by the Garbage truck. Chairman Andy will notify Advanced Disposal about this incident. Our Annual Township Picnic will be tentatively scheduled for Saturday, August 12, 2017 at 1:00 p.m.: Everyone is welcome to come, bring a dish to pass. The township will provide the basics including grilling meats.

**ROADS/CULVERTS:** Brad Goetz with the help of John Ceyress Trucking installed the new double culverts on Sherwood Road West of the town hall. To date, we have not received a bill from Brad Goetz.

**GRAVEL:** After the Road Tour last month, a motion by Ken Schwanebeck,, seconded by Curtis Anding to hire John Ceyress Trucking again this year for approximately 2,000 yards, ½" gravel at a cost of \$10.60 per yard. Motion carried.

**FEMA:** Chairman received letter from John Ross, Director of Emergency Management Department at the Clark County Courthouse. There are more things that need to be signed from FEMA regarding the flooding we had last year. The amount we will receive is \$6907.00.

**NO-WAKE LAKE ORDINANCE:** The town board discussed the no-wake lake ordinance. Chairman Andy will look into other lakes in Clark County to see if they have no-wake lake ordinances and if they do how are they policed and managed first. Therefore a motion by Chairman Andy, seconded by Ken Schwanebeck to table this topic until the June 2017 meeting.

**TAX EXEMPT LAND-FIX HYDRANT:** The current landowner does not want water taken out of Neal's pond for emergencies when needed. John Ceyress offered the use of his pond for installing a water hydrant. His pond is located on Anderson Road. If Poochi does not follow through on making his land updated for a legal tax exempt foundation, his tax exempt status can be pulled. We will give him another year to get the structures up for the Take-A-Kid Hunting



Foundation.


**WEB PAGE:** The township web page set-up is started. The site to get on this is townofsherwood.com. and there is a history of our township including pictures and we are looking for new ideas to put on it. Sam Draeger is setting it up for us and will train us on how to use it.

**DUST CONTROL:** Wisconsin Salt Solutions, Mosinee sent the following quotes: 4,500 gallons-price includes delivery, application & fuel surcharge. Calcium Chloride, 38% solution is \$1.015 per gallon and Magnesium Chloride, 30% solution is \$.98 per gallon. After some discussion a motion by Ken Schwanebeck, seconded by Curtis Anding to buy one load of Magnesium Chloride and hopefully have it delivered before July 4<sup>th</sup>, 2017. Motion carried.

**BRUSH CUTTING:** JJ Brush Cutting Service of Loyal, Wisconsin sent 2017 bids for mowing roadside grass at a charge of \$65.00 per hour and any brush cutting for \$75.00 per hour. These prices are the same as 2016 and 2015. Therefore a motion by Ken Schwanebeck, seconded by Curtis Anding to hire JJ Brush Cutting Service to mow town roads at least once and two passes when necessary. Motion carried.

**PAY BILLS:** Board approved checks #3607 through #3619. Our next town board meeting will be held Tuesday, June 13, 2017 at 6:00 p.m. at the Sherwood Town Hall. A motion by Andy Cegielski, seconded by Ken Schwanebeck to adjourn. Motion carried. Meeting adjourned. (7:30 p.m.)
