

# 2017--TOWN OF SHERWOOD, CLARK COUNTY, WI. DECEMBER TOWN BOARD MEETING

December 12, 2017

The Town Board of Sherwood met Tuesday, December 12, 2017 at 6:00 p.m. at the Sherwood Town Hall. All town board member including clerk & treasurer present. There were no town electors present. This notice was published in the Pittsville Record and posted in three places within the township at the town hall, Roadhouse Bar & Grill and on the substation on County Road W. The agenda as follows: call to order, approval of minutes by town board, treasurer's report, town correspondence, reports from town officers & committees, public comments upon recognition of the chairman, specific matters for discussion & possible action by the town board in open session-- updates on beavers & roads and election workers for 2018-2020, pay bills and set town board & board of audit meeting for 2018 and adjournment.

Chairman Andy Cegielski called this meeting to order. The Pledge of Allegiance was recited. Minutes of the previous town board minutes were read. A motion by Ken Schwanebeck, seconded by Curtis Anding to accept the minutes as read. Motion carried. Treasurer Peggi Schwanebeck gave the treasurer's report. As of November 30, 2017 was have on hand \$24,448.87 in our checking account. Last month we received a check in the amount of \$6907.52 from the FEMA disaster we had previously.

**MEETINGS:** Chairman Andy Cegielski attended the last months WTA regional meeting. Updates were given on possibility of having the Open Book and Board of Review on separate days, but no determination was made as of this date.


**CORRESPONDENCE:** Chairman Andy Cegielski received information that the Clark County Courthouse will handle the 2020 census for our township so Treasurer Peggi Schwanebeck can throw her paperwork away. A landowner from Badger Avenue North has some junk in the ditch. Tim Freek of All Seasons Tree Service sent an estimate of \$600.00 to grind up 6-stumps and remove the residue by the cemetery. Chairman will hold on to this offer until early spring before acting on it. Received letter from Paul Drescher, Neillsville asking that the township does not scrape the gravel on Poertner Road from County Road W to County Road K so that the snowmobiles have more of a snow base for this sport. John Wendorski will look into possible using the back road out of the lake to Dyer Road for the pulpwood/log removals. Logging is in progress from the County land behind Phillip Freedlund and Jerry Jacobson's land. The County used GPS to update County lines there also.

**PUBLIC COMMENTS:** Chairman Andy Cegielski will be out of town from January 5<sup>th</sup> thru March 5<sup>th</sup>, 2018. The WTA county meeting scheduled for February 24<sup>th</sup> in Neillsville will be attended by the clerk and possibly Supervisor Ken Schwanebeck for re-certification for Board of Review. This is done every 2 years. Last August Albert & Tracey Havlik moved out of our township so this house has been vacant since then.

**ELECTION WORKERS FOR 2018-2020:** There are -7- election workers--Marla Martin, Rochelle Pederson, Charles Pederson, Rose Rakovec, Paula Schafer, Theresa Mallory & Joan Kumm. Our township has in effect an ordinance for split shifts for the last 4 years if necessary. Therefore a motion by Andy Cegielski, seconded by Ken Schwanebeck to accept the election workers list as presented. Motion carried.

**PAY BILLS:** Board approved check #3705 through #3718. Our next town board meeting and Board of Audit will be held on Tuesday, January 9, 2018 at 6:00 p.m. at the Sherwood Town Hall. A motion by Andy Cegielski, seconded by Curtis Anding to adjourn. Motion carried. Meeting adjourned. (7:15 pm.)
