

2018--TOWN OF SHERWOOD, CLARK COUNTY, WI. JANUARY TOWN BOARD MEETING

January 9, 2018

The Town Board of Sherwood met Tuesday, January 9, 2018 at 6:00 p.m. at the Sherwood Town Hall. Supervisor I, Kenneth Schwanebeck, Supervisor II, Curtis Anding, Clerk, Alene Jacobson and Treasurer Margaret Schwanebeck were present. Chairman Andrew Cegielski was absent because he was on vacation out of State. There were no town electors present. This notice was published in the Pittsville Record, and posted in three places within the township--at the town hall, Connie's Roadhouse Bar & Grill and at the substation on County Road W. The agenda as follows: call to order, approval of minutes by town board, treasurer's report, reports from town officers, town correspondence, specific matters for discussion & possible action by town board in open session-taxes-dogs, updates on roads & beavers and WTA-re-certification for Board of Review, pay bills, set town board meeting for February 2018 and adjournment.

Supervisor Ken Schwanebeck called this meeting to order. The Pledge of Allegiance was recited. Minutes of the previous meeting were read. A motion by Curtis Anding, seconded by Ken Schwanebeck to accept the meeting as read. Motion carried by 2/3 majority. Treasurer Peggi Schwanebeck gave the treasurer's report. Tax collections are going well. As of December 31, 2017 we have on hand and carried into 2018 \$21,760.07.

MEETINGS: None.


