## 2017-TOWN OF SHERWOOD, CLARK COUNTY, WI. OCTOBER TOWN BOARD MEETING

October 17, 2017

The Town Board of Sherwood met Tuesday, October 17, 2017 at 6:00 p.m. at the Sherwood Town Hall. Supervisor Ken Schwanebeck, Supervisor Curtis Anding, Clerk Alene Jacobson & Treasurer Margaret (Peggi) Schwanebeck present. Chairman Andrew Cegielski is absent because he is out of town. There were no town electors present.

This meeting notice was published in the Pittsville Record and posted at the town hall, Connies Roadhouse Bar & Grill and at the substation on County Road W. The agenda as follows: Call to order, approval of last month's minutes by town board, treasurer's report, town correspondence, reports from town officers, public comments upon recognition of the chairman, specific matters for discussion & possible action by town board in open session: 2018 assessor contract, roads updates, web page, beaver's updates, pay bills & set town board, budget & levy meetings for November 2017 and adjournment.

Supervisor Ken Schwanebeck called this meeting to order. The Pledge of Allegiance was recited. After the minutes of the previous town board meeting were read, a motion by Curtis Anding, seconded by Ken Schwanebeck to accept the minutes as read. Motion carried by 2/3 majority. Margaret Schwanebeck gave the treasurer's report. As of September 30, 2017, we have on hand \$23,263.89.

CORRESPONDENCE: Received application for a Treasurer's Bond for tax collection. In the last two years the town board decided not to purchase a Treasurer's Bond for tax collection. Discussion, but no action taken at this time. Clerk will ask Rural Insurance if they issue these bonds and the item will be on the agenda in November for possible action.

**MEETINGS**: None attended.

<u>PUBLIC COMMENTS:</u> As of this date, the bill was not received for the road resurfacing done on Badger Avenue South & Dyer Road to the Lake. H&S Manufacturing, owners of land on the end of Todd Road would like to know where their land starts as the road is a dead-end road and they would like to install a gate to keep strangers off their land. The beavers on Anderson Road miss Andy Cegielski as the dams are holding back a lot of water.

2018 ASSESSOR CONTRACT: Assessor Mark Garlick of Chimney Rock Appraisals sent a copy of the 2018 Assessor Contract, notification of insurance and the contract price for 2018 at a cost of \$4,100. After discussing this contract, a motion by Ken Schwanebeck, seconded by Curtis Anding to accept this contract with a \$300 raise. Motion carried by 2/3 majority.

<u>PAY BILLS:</u> Board approved checks #3681 through #3689. Our next town board meeting, budget & levy meeting will be held on Tuesday, November 14, 2017 at 6:00 p.m. at the Sherwood Town Hall. A ,motion by Ken Schwanebeck, seconded by Curtis Anding to adjourn. Motion carried by 2/3 majority. Meeting adjourned. (6:40 pm.)
