JULY TOWN BOARD MEETING
July 8, 2019

The Town Board of Sherwood was called to order on Monday, July 8, 2019 at 6:00 pm at the Town Hall. All Town Board members were present including clerk & treasurer. Travis Kumm was also present.

This meeting notice was published in the Pittsville Record and posted in -3- places within the township. The agenda as follows: call to order, approval of minutes by Town Board, treasurer's report, town correspondence, reports from town officers, public comments upon recognition of chairman, specific matters for discussion & possible action by town board in open session--grader purchase updates, gravel bids & roads updates, ditch mowing updates, town hall furnace & town hall porch addition updates, fire numbers - Beavers updates, township picnic updates, pay bills, set town board meeting for August 2019 and adjournment.


Chairman Andy Cegielski called this meeting to order at 6:00 pm. Minutes of the previous meeting were read. (There were a few typo errors brought to my attention.) After these errors were corrected, a motion by Chairman Andy Cegielski, seconded by Supervisor Ken Schwanebeck to approve the minutes. Motion carried. Peggi Schwanebeck gave the treasurer's report. As of June 2019, we have \$58,143.88 in the township's checking account.

UPDATES AS NOTED: Matt Weber notified Chairman Andy recently that there are no beavers on Anderson Road. He plans on checking again this fall and possible next spring too. The Clark County Sportsman's Club would like a Temporary One Day license to sell beer at their upcoming picnic on July 21st at the Sherwood Lake Shelter house. They will have a free lunch with beer & soda. The town board unanimously agreed at a cost of \$5.00 and operators license for \$1.00. After this year, there will be a license increase to correspond with our times now. (The last license was issued in 2011). Joe Geiger contacted Chairman Andy about the possible improvements that need to be done to the township garage. No action done at this time though. The two passes, mowing ditches in the township are completed, but Lonny Roth still plans on mowing in further on some township roads to clean the ditches better with different mowers. Cooper Gas of Stevens Point will be sending a contract offer for 2019-2020 heating fuel soon. Rent-A-Flash will let Chairman Andy know when the replacement address signs are ready for pick-up. (Hopefully before winter.) The Township picnic is rescheduled for September 14, 2019. The County was notified and we have that date settled. Information collected regarding grader replacement is still being considered. No decisions have been made at this time. The town board will keep working on this matter and discuss the payment options including a possible down payment out of our operating funds.

PAY BILLS: Board approved checks #4013 through #4030. Our August town board meeting will be held on Monday, ~~August 12, 2019~~ at 6:00 p.m. at the Sherwood Town Hall. A motion by Ken Schwanebeck, seconded by Curtis Anding to adjourn. Motion carried. Meeting adjourned. (7:05 pm)
