## 2020-Town of Sherwood, Clark County, WI. April Town Board Meeting April 21, 2020

The Town Board of Sherwood met Tuesday, April 21, 2020 at 6:00 pm at the Sherwood Town Hall. All town board members including Clerk & Treasurer were present. There were no town residents present. This meeting was scheduled for Wednesday, April 15<sup>th</sup> but due to all unsatisfactory conditions regarding the Covid-19 pandemic and the need to reschedule the Annual Meeting to a later date, the town board decided to schedule the April town board meeting on the same day as the Annual Meeting to get all business done in April.

All notices and any rescheduling were posted within the township. The agenda for the April 2020 meeting is as follows: call to order, approval of minutes by Town Board, town correspondence, reports from town officers, public comments and matters for discussion & possible action by the town board in open session, 50-50 Town Road Grant updates, removal of storm damage at cemetery, road & town garage updates, Annual Meeting rescheduling, pay bills, set town board meeting for May 2020 and adjournment.

Chairman Andy Cegielski called this meeting to order. The Pledge of Allegiance was recited. Minutes of the previous meeting were read. A motion by Ken Schwanebeck, seconded by Curtis Anding to accept the minutes as read. Motion carried. Peggi Schwanebeck gave the treasurer's report. As of March 31, 2020 we have on hand \$5957.27 after all taxes were paid. This month we will receive transportation aids in the amount of \$16,779.78.

TOWN CORRESPONDENCE & UPDATES: Chairman Andy informed us that we did not get the 50-50 grant that we applied for, maybe our bid was too low. Travis Kumm will be hired to repair the damaged mold board on the new grader. The repair will be done in Richard Kumm's garage and anyone helping will be reimbursed. Insurance is functional for this project. Due to the lockdown state-wide regarding the pandemic, the lake grounds is closed until further notice. Lonnie Roth sent chairman a bid for ditch mowing in 2020, \$52.00 per hour. Discussion only on repairing the siding on the town hall.

**2019 STORM DAMAGE AT CEMETERY:** Chairman received a bid from Arbor Vantage, LLC, 4220 Dairy Road, Arpin, WI. 54410 (phone: 715-652-2770) to remove 2 white pines, leaving wood in field & piling brush & grinding stumps with full clean up, topsoil and lawn seed for \$2,425.00. We do not pay sales tax. There could be more jobs added to this quote. Therefore a motion by Andy, seconded by Ken to hire Arbor Vantage for this project. Motion carried. Andy will look into this project for more options.

GARAGE DOORS: A spring broke on the garage door. Ken Schwanebeck hired Door Pro Overhead Doors of Stratford to replace parts on the door at a cost of \$502.

**ROOD TOUR:** The annual road tour sill take place on May 6, 2020. Notice will be posted by Chairman Andy and will convene at 4:00 pm at the town hall.

<u>PAY BILLS</u>: Board approved checks #4182 through #4200. Our next town board meeting will be held Wednesday, May 13, 2020 at the Sherwood Town Hall. A motion by Andy, seconded by Ken to adjourn. Motion carried. Meeting adjourned. (6:45 pm)
