

**2020--TOWN OF SHERWOOD, CLARK COUNTY, WI. canc**  
**AUGUST TOWN BOARD MEETING**  
**August 12, 2020**

The Town Board of Sherwood met Wednesday, August 12, 2020 at 6:00 pm at the Sherwood Town Hall. All town board members present including clerk & treasurer. There were no town residents present.

The agenda as follows: call to order, approval of minutes by town board, treasurer's report, town correspondence, reports from town officers, public comments, matters for discussion and possible action by town board in open session--insulation town garage & fan, updates roads-gravel for this year, Beavers, Anderson Road=Lynn Moeller, LP Gas Contract, crack seal Badger Avenue North, Badger Avenue South & Dyer Road, potholes cancelled, garbage/recycling meeting set for 9/15/2020, Pay bills, set town board meeting for September 2020, and adjournment.

Chairman Andy called this meeting to order. The Pledge of Allegiance was recited. Minutes of the previous meeting were read. Clarification of statement was made--Lynn Moeller volunteered to be hired to remove the beavers on Anderson Road in 2020. After this clarification was acknowledged a motion by Ken Schwanebeck, seconded by Curtis Anding to approve the minutes as read. Motion carried. Peggy Schwanebeck gave the treasurer's report. We have on hand as of July 31, 2020-- \$12,307.71.

**GARBAGE/RECYCLING MEETING:** Discussion on the upcoming contract with the surrounding townships regarding curb-side pickup is scheduled for Tuesday, September 15, 2020 at 7 pm at the Sherwood Town Hall. Advanced Disposal, Country Disposal & Express Disposal will be discussed before determination on which company to go with in 2021.


**CRACK-SEAL BADGER AVENUE NORTH:** Fahrner crack sealed Badger Avenue North recently. At this time we did not receive the bill so it will be paid next month.

**MISCELLANEOUS:** Dan Ostrowski ordered a culvert through Chairman Andy and we will wait for the bill. Chairman Andy ordered posts recently. At this time Badger Avenue South and Dyer Road will not be chip-sealed. We will consider this project in 2021. The holes will be patched up yet this fall. Lynn Moeller volunteered to be hired to remove the beavers on Anderson Road in 2020. Therefore a motion by Andy seconded by Ken to hire Lynn Moeller to remove all beavers and pay him \$700 in August and \$800 in December for this job. Motion carried. Guy Mayer's property--The DNR and County does not want to do anything about the junk on his property and we have no jurisdiction. Discussion on how many loads of gravel, possibly 50 loads and to be delivered next month, Discussion on pre-buying propane from Cooper Oil or Krist Oil. Andy will check in on this before our board meeting in September.

**INSULATION TOWN GARAGE:** Discussion on who to hire for spraying insulation in the garage before winter. Willy Hochstetler from Blair, WI. Or Ryan Woiak from Alpine. Prices are the same, but the town Board has not come to a final decision yet. We would consider buying a fan and install it soon. A motion by Andy, seconded by Curtis to install the ceiling fan in garage this fall and put the insulation installation on hold until 2021. Motion carried. David Borntrager will remove the paddles off the roof and leave the rail on until 2021.

**PAY BILLS:** Board approved checks #4255 through #4275. Our next town board meeting will be held Saturday, September 12, 2020 at 9:00 am at the Sherwood Town Hall. A motion by Ken, seconded by Curtis to adjourn. Motion carried. Meeting adjourned. (7:35 pm)
