2020--TOWN OF SHERWOOD, CLARK COUNTY, WI. OCTOBER TOWN BOARD MEETING

October 10, 2020

The Town Board of Sherwood met Saturday, October 10, 2020 at 9:00 am at the Sherwood Town Hall. All town board members present. Clerk Alene Jacobson was present. Treasurer Margaret Schwanebeck was absent because she was called into work. There we no town residents present.

The agenda as follows: call to order, approval of last months minutes by town board, treasurers report, town correspondence, reports from town officers, public comments upon recognition of the chairman, specific matters for discussion and possible action by town board in open session: garbage/recycling updates, roads-gravel updates, Opelt for sanding/salting in 2020-2021, grader operators for snowplowing in 2020-2021, beavers updates, sign contact for Pittsville Fire & EMS for 2021, grass/brush cutting by JJ Brush Cutting Service, Pay Bills, set Town Board, Budget & Levy for November 2020 and adjournment.

Chairman Andy called this meeting to order. The Pledge of Allegiance was recited. Minutes of the previous meeting were read. A motion by Ken Schwanebeck, seconded by Andy Cegielski to approve the minutes as read. Motion carried. The treasurer's report was read by all and discussed.

MISCELLANEOUS INFORMATION DISCUSSED: Chairman Andy updated us on the LTRIP program that was received from the Clark County Courthouse regarding the townships that applied for this in 2020 for road improvements. We did not apply for this program since 2016. Chairman Andy called Advanced Disposal regarding the new contract we updated on Garbage/Recycling last month. They said it will cost us \$12.50 per month in 2021. We will get a new 95 gallon container and they will send an email to Andy for a copy of this new contract. We will probably have to replace a culvert on Sherwood Road West soon. We are considering on hiring Rick Schwanebeck as a back-up person this winter for snowplowing roads when Ken or Travis is not available. Opelt's Sand & Gravel from Neillsville agreed to sand/gravel our roads this winter when called to come. JJ Brush Cutting Service will not cut the township ditches this fall. It is not necessary. Ballard Road towards the Lake, beavers were moving in.

<u>LEVY ADJUSTMENT</u>: A motion by Andy, seconded by Ken to adopt a resolution to raise the levy by \$5,000 this fall at the LEVY meeting that will be held in November 2020. Motion carried. The WTA stated that we need a noticed meeting of the taxpayers, which will be held in November. This will be a one timer and the public must be notified.

PAY BILLS: Board approved checks #4288 through #4293. Our next town board meeting, Levy Meeting & Budget Meeting will be held on Tuesday, November 10, 2020 at 6:00 pm at the Sherwood Town Hall. A motion by Andy, seconded by Curtis to adjourn. Motion carried. Meeting adjourned. (10:05 am)
