

**2022--TOWN OF SHERWOOD, CLARK COUNTY, WISCONSIN
MARCH TOWN BOARD MEETING
MARCH 12, 2022**

The Town Board of Sherwood was called to order on Saturday, March 12, 2022 at 9:30 am at the Sherwood Town Hall. Supervisor Ken Schwanebeck, Supervisor Rick Schwanebeck, Clerk, Alene Jacobson, and Treasurer Peggi Schwanebeck were present. Chairman Andy Cegielski was absent because he was out of town. There were ~~town~~ no town residents present.

Agenda as follows: call to order, Pledge of Allegiance recited, reading and approval of last month's minutes, treasurer' report, town correspondence, reports from town officers, public comments for discussion and possible action by town board--recycling/garbage updates, Rural Insurance updates, board of Review & Open book dates to be approved, , beavers updates, and updates on election for April 2022. Setting board meeting for April and pay township bills and adjournment.

It is noted that the 50/50 grant is a county orientated loan to help with road improvements within our county. We have \$128273.84 in our checking account, We have -3- outstanding checks totaling \$77433.04 leaving an actual total of \$50840.80 in checking. The state of Wisconsin COVID money is \$11461.21 in checking account too.

MISCELLANEOUS: The Open Book and Board of Review meetings are May 4, 2022 from 1-3 pm and May 17, from 6-8 pm requested by the Assessor. Chairman Andy Cegielski is coming back to Wisconsin the first week of April and we will let Mark Garlick know if we will go with his dates. (home 4-3-2022). Ian Pierce, career agent from Rural Insurance came here at 10:00 am and updated us on any changes that would work for us in 2022. After all questions were answered and he explained all coverage's we have, his explanations truly helped us. Supervisor Rick Schwanebeck will be added on as a grader operator when needed and his drivers license is requested by Rural Insurance for coverage. Pay Bills: Board approved checks #4557 through #4566. Our next town board meeting will be held on Saturday, April 9, 2022 at 9:30 am at the Sherwood Town Hall. Therefore a motion by Ken Schwanebeck, seconded by Rick Schwanebeck to adjourn. Motion carried by 2/3 majority. Meeting adjourned. (10:30 am
