ANNUAL MEETING
TUESDAY, APRIL 19, 2022**

The Annual Meeting of the Town of Sherwood was called to order on Tuesday, April 19, 2022 at 7:00 pm at the Sherwood Town Hall. The following electors were present--Chairman Andrew Cegielski, Supervisor--Kenneth Schwanebeck, Supervisor --Rick Schwanebeck, Treasurer--Peggi Schwanebeck, Clerk--Mrs. Alene Jacobson, Cheryl Haupt-Cegielski, Karen Fluegel, Lowell Freedlund, Marla Martin, Ron Martin, Linda Schwanebeck, and Arnold Schwanebeck. 
This meeting was called to order at 7:00 pm. The Pledge of Allegiance was recited. After the minutes of the 2021 were read, a motion by Ron Martin, seconded by Cheryl Cegielski to accept the minutes as read. Motion carried by all 12 electors. The Annual Report was discussed and all questions answered. The typographic errors were corrected and the electors would like more breakdowns in some of the generalized items on the Annual report such as what is in miscellaneous and office expenses. After a motion by Ron Martin, seconded by Peggi Schwanebeck to accept the Annual report with suggested changes. Motion carried by all 12 electors.

Karen Fluegel gave an updated presentation on the Granton Area First Responders calls in 2021. There was 144 total calls. Our township had -8- medicals, no accident calls and no fires in 2021. Linda Schwanebeck gave a presentation on the history and some important events on a computer screen. Life Link is the helicopter name they use now for help. Albert Bucheger is joining the Granton Area First Responders to help out in the future. After this news, a motion by Ken Schwanebeck, seconded by Rick Schwanebeck to donate \$2,500 to the GAFR. Motion carried by all 12 electors.

A motion was made by Ron Martin, seconded by Rick Schwanebeck to donate \$100 to the Clark County Humane Society. Motion carried by all -12- electors.

On April 27, 2022 the Pittsville Fire Department will be open from 10 am to 1 pm in Pittsville to update & test the public's fire extinguishers. Chairman Andy will file with the State a report on the ARPA funds given to our township last year. We may have to have a revaluation soon as our assessment values are rated less than .90%. Discussion on various topics brought up, like possible raising the township levy, safe move to town hall, cemetery info, flags & holders' A motion by Ken Schwanebeck, seconded by Ron Martin to leave all special charges and wages the same as last years. Motion carried by all -12- electors. A motion by Lowell Freedlund, seconded by Peggi Schwanebeck to pay \$25.00 to all experienced grader operators. Motion carried by all 12 electors. Memorial Day meal is sponsored by the Town of Sherwood in 2022. The Annual Picnic tentatively will be on Saturday, August 13 or on August 20, 2022, which date we can have. The 2023 Annual Meeting will be held on the 3rd Tuesday in April Therefore a motion by Ron Martin, seconded by Ken Schwanebeck to adjourn. Motion carried by all 12 electors. Meeting adjourned.
