

# 2023-TOWN OF SHERWOOD, CLARK COUNTY, WISCONSIN

## APRIL TOWN BOARD MINUTES

April 8, 2023

The Town Board of Sherwood was called to order on Saturday, <sup>APRIL</sup> ~~March~~ 8, 2023 at 9:29 AM at the Sherwood Town Hall. Supervisor I, Ken Schwanebeck, Supervisor II, Rick Schwanebeck, Treasurer Margaret "Peggi" Schwanebeck and Interim Clerk Bill Rosandick were present. Chairman Andy Cegielski was excused. Also present was town Treasurer elect Jessica Bucheger, Albert Bucheger, Liam Bucheger, Hallie Bucheger, Bob Fluegel and Nathan Hass.

The notice was published in the Pittsville Record, posted at the town hall and at the Sherwood Electrical Substation.

Agenda as follows: call to order, pledge of allegiance, reading and approval of last month's minutes, treasurer's report and town correspondence, town officer's report, public comments, oath/swearing in of newly elected town officials, April 4 election overview, April 18 meeting, pay bills, set Town Board meeting for May, set date for Annual Town Board Meeting and adjournment.

Supervisor I Ken Schwanebeck called the meeting to order. The pledge of allegiance recited. After the minutes from the February meeting were read, a motion by Ken Schwanebeck second by Rick Schwanebeck to approve the minutes as read with one amendment (adding the sentence that the meeting in April will be open to all town residents but no official business will be conducted) which will be amended by Interim Clerk Rosandick. Motion carried. The treasurer's report was read and discussed.

Agenda and Miscellaneous items: There were no questions from town members present.

April 4 election results for township positions were as follows. Elected were: Andy Cegielski, Town Chairman, Ken Schwanebeck, Supervisor 1, Rick Schwanebeck, Supervisor II, Margaret "Peggi" Schwanebeck, Town Clerk and Jessica Bucheger, Town Treasurer. Interim Clerk Rosandick gave each newly elected member an oath of office form which they signed. He also went over the election results from the April 4 election. A total of 90/169 (54%) of eligible voters voted. This was above the state average of about 50%.

A Town Board meeting will be held on Tuesday, April 18. This meeting will be open to all town residents but no official business will be conducted. The meeting will be called to order, no business conducted, then adjourned. The Annual Meeting is scheduled for Tuesday, May 16 at 6:30 PM. Notices will be placed in the Pittsville Record, Town Hall and Sherwood substation.

PAY BILLS: Board approved checks 4776 through 4800. Our next board meeting will be held on Saturday, May 13, 2023 at 09:30 AM. A motion to adjourn was made by Ken Schwanebeck, seconded by Rick Schwanebeck. Motion carried. Meeting adjourned at 10:18 AM.
