## MARCH TOWN BOARD MINUTES

## March 9, 2024

The Town Board of Sherwood was called to order on Saturday March 9, 2024 at 9:00AM at the Sherwood Town Hall. Supervisor, Ken Schwanebeck, Supervisor, Rick Schwanebeck, and Clerk, Margaret "Peggi" Schwanebeck were present. Resident Lowell Freedlund and Marla Martin were present.

The notice was posted at the Sherwood Town Hall, the Pittsville Record, the Roadhouse Bar & Grill and at the Sherwood Electrical Substation.

Agenda as follows: call to order, pledge of allegiance, reading and approval of last month's minutes, treasurer's report and town correspondence, Reports from the town officers. Continuing Business, Public comment (upon recognition of chairman), Pay bills, set date for April 2024 town meeting, and Adjournment.

Supervisor Ken Schwanebeck called the meeting to order at 9:00AM. The pledge of allegiance was recited. Minutes from the February 9,2024 meeting were read. Ken S. made a motion to accept the minutes with a correction of the 2023 date changed to 2024 in the minutes, and it was seconded by Rick S. The motion passed.

The Treasurer's report was read by the clerk. We have \$111,006.58 in the bank on February 29, 2024.

## **Continuing Business:**

- a. Supervisor Rick S. reported on the Culvert inventory: 9 double culvert and one box culvert on Ballard Rd. Rick went to the WTA meeting where all the townships are confused about doing the inventory.
- b. JJ Brush Cutting: Brush was cut along Ballard, Sherwood, Poertner, Badger and Dyer roads.
- c. Personal Property tax appeal. The Personal Property tax was to end in 2023. The Assessors do not know how Personal Property will be taxed.
- d. Cemetery Expansion Project work: Lowell tried to get an appraisal of the land. The Appraisers that he spoke with were not interested but did explain how the appraisal would be done. Lowell asked if we had funds to make an offer if approved by the town residents. It was not budgeted for, but we have money. Lowell will speak again to Dr Yao and Lee Mc Doanld their price. All information to the Annual Town meeting to present to the town residents.
- e. ATC high voltage powerline is in the planning stage but is expected to run thru Sherwood. The project start date is 2027 with completion in 2030. There will be meetings in April.

- f. 150 year Celebration: Neals pond is available.
- g. ARIP program: We are not applying for this money because of the restrictions built into the loan.
- h. Election: April 2<sup>nd</sup>,2024: Marla Martin is working on the Absentee Ballots. We will post notice according to Wis. Election laws. We will post testing times prior to the date.
- i. Dirt Bros Excavating bill was sent to Clark County Parks and Forestry. We received payment.
- j. Open Book is April 26,2024 from 2:00pm to 4:00pm.
- k. Board of Review is May 20th, 2024 from 6:00pm to 8:00pm.
- 1. Annual Meeting is scheduled for April 16th,2024 to 6:00pm. At this meeting we will adjourn the meeting to May11th,2024 at 10:00am.
- m. The board approved checks #s 4961 to 4973.
- n. The next Board meeting be Saturday 13,2024 at 9:00AM at the Sherwood Town Hall.
