

**2024 ---SPECIAL MEETING---TOWN OF SHERWOOD  
CLARK COUNTY, WI 54466**

**August 1,2024 06:30 PM**

The Special Meeting of the Electors of the Town of Sherwood, Clark County, WI was called to order on August 1,2024 at 6:30 pm at the Sherwood Town Hall. The Following Electors were present— Chaiman- Andy Cegielski, Supervisor- Ken Schwanebeck, Supervisor- Rick Schwanebeck, Clerk- Margaret Schwanebeck, Treasurer-Jessica Bucheger, Lowell Freedlund, Robert Fluegel, Rich Kumm, Joan Kumm, Phil Freedlund, Bill Rosandick, Marla Martin, Ronald Martin, Albert Bucheger, and Linda Schwanebeck.

The meeting was called to order at 6:30 pm. The Pledge of Allegiance was recited.

Cemetery: Lowell Freedlund gave a presentation on the Sherwood cemetery. Lowell explained what has been done so far by the board. Margaret and Lowell spoke of the meeting with Harold Wolfram (lawyer) and of his suggestions for the process to purchase the 2 plots of land to the south of the cemetery. Questions by several electors were answered by Lowell F., Margaret S., and Andy C. This meeting is to get the approval to purchase the land from the electors. Bill Rosandick explained how St Joachim's Catholic Church in Pittsville had purchased land and has yet to put it to use, and their reasoning for purchasing when they did.

The motion was seconded by Ronald Martin. 15 Ayes, 0 Nays, 0 Abstain, 0 not voting. The motion passed.
