2024 TOWN OF SHERWOOD

CLARK COUNTY, WISCONSIN

November 12th,2024

The meeting of the Town Board of Sherwood was called to order on Tuesday, November 12th,2024, at 6:46 pm at the Sherwood Town Hall, W896 Sherwood Rd, Granton, WI. Chairman Andy Cegielski, Supervisor, Ken Schwanebeck, Supervisor, Rick Schwanebeck, Treasurer, Jessica Bucheger and Clerk, Margaret "Peggi" Schwanebeck were present. Residents: Albert Bucheger, Bill Rosandick and Lowell Freedlund were present.

The notice was posted in the *Pittsville record*, at the Sherwood Town Hall, the Roadhouse Bar & Grill and at the Sherwood Electrical Substation.

Agenda as follows: call to order, pledge of allegiance, reading and approval of last month's minutes, treasurer's report and town correspondence, Reports from the town officers. Continuing Business, Public comment (upon recognition of chairman), Pay bills, set date for the December Town Board meeting, and adjournment.

Chairman Andy C. called the meeting to order at 6:46pm. The pledge of allegiance was recited. Minutes from October 15th, 2024, was read. Ken S. made a motion to accept the October minutes with the correction of the date (Dec.15,2024) for the deadline for the Bridge and Culvert Inventory, and it was seconded by Rick S. The motion carried.

The Treasurer's report was given. We have \$69197.00 in the bank on October 31st, 2024.

Continuing Business:

- a. Correspondence: Andy C. received a quote from Opelt's Sand and Gravel for the Sanding and Salting of the town roads. Costs is: sanding and salting is \$110.00/hour. The cost of salt-sand is \$25.00/ yard.
- b. Cemetery Expansion Project: Julie from Wolfgram, Gamoke, & Hutchinson, S.C. sent an email with the letter to McDonald's. Questions were raised about the property description written by the lawyer. It was decided that the clerk would contact the courthouse about possible land surveys of either property. Then a survey would be done on the Yao/Sun property. The section lines on the county map shows that the cemetery land goes north across Highway 73. The clerk will report back to Andy C. and Lowell F. with her findings.
- c. Roads: Culvert inventory was done by Andy C. and Rick S. and the information will be put on the spreadsheet for the county, by the clerk. We will not be taking care of Meridan north, Cherry Rd and Poertner Rd. The agreement from 2015 will be revisited in May 2025

- d. GAFA contract: Andy C, town chairman, spoke to Ronald Vine the president of the GAFA. According to Mr. Vine, old statutes says that the town is responsible for the residents and therefore, will have to pay any bills from the GAFA. He did not state what the statue numbers were.
- e. Andy C. received a report from the WI DOR on the valuation of Ag land. When the town of Sherwood had the Re-val done in 2023, we were at 100% compliance and now we are at 86.5%. This is due to the 20% inflation in land sales value. We will have to have a Market Re-val in at least 2 yrs.
- f. Furnaces: Andy C. will find a furnace repair service to inspect our Hall and Garage furnaces.
- g. Election: The was a 96% turnout of town residents to vote!! The process for the voters went very smoothly according to Bill Rosandick. The Town of Sherwood Thanks Marla Martin for all of the time and effort she put into the voting processes. Thank you to Debra Kohl, Bill Rosandick, Rose Mueller and Peggy Winters for their part of the voting process.
- h. The December meeting will be Dec. 10th,2024 at 6:30pm pm at the Sherwood Town Hall.
- i. Cell Tower: the tower is up but Verizon must put up their hardware. No light at the top of the tower at the present time.
- j. Amotion to approve the Budget and the Levy was made by Ken S. and seconded by Andy C. the motion passed.
- k. The board approved checks #s 5074 to 5115.
- 1. A motion by Ken S. and seconded by Rick S. to adjourn. The motion carried
