January 18th, 2025

The meeting of the Town Board of Sherwood was called to order on Saturday January 18th, 2025 at 10:06am at the Sherwood Town Hall, W896 Sherwood Rd, Granton, WI. Supervisor Ken Schwanebeck, Supervisor, Rick Schwanebeck, Treasurer, Bill Rosandick and Clerk, Margaret "Peggi" Schwanebeck were present. Residents: Lowell Freedlund, Tony Balsiger, Samantha Balsiger, Travis Kumm, and Marla Martin were present.

The notice was posted at the Sherwood Town Hall, the Roadhouse Bar & Grill and at the Sherwood Electrical Substation, and *The Pittsville Record*.

Agenda as follows: call to order, pledge of allegiance, reading and approval of last month's minutes, treasurer's report and town correspondence, Reports from the town officers. Continuing Business, Public comment (upon recognition of chairman), Pay bills, set date for the February 2025 Town Board meeting, and adjournment.

Supervisor Kenneth Schwanebeck called the meeting to order at 10:06am following the Caucus Meeting. The minutes from the December 10th, 2024 meeting was read. Rick S. made a motion to accept the minutes as read. The motion was seconded by Ken S. The motions carried.

The Treasurer's report was given. We have \$172,333.31 in the bank on December 31st, 2024. Bill R. had about 25 phone calls from property owners who had questions about the increase in their taxes. He also spoke of the errors on two MFL properties. Margaret S. explained how she spoke with the Assessor about correcting the error on his paperwork, and how she will correct the error with the Wis. Dept. of Revenue. Thank you to Bill R. for his work with the property owner!
