The meeting of the Town Board of Sherwood was called to order on Saturday February 15th, 2025 at 9:00am at the Sherwood Town Hall, W896 Sherwood Rd, Granton, WI. Supervisor Ken Schwanebeck, Supervisor, Rick Schwanebeck, and Clerk, Margaret "Peggi" Schwanebeck were present. Residents: Lowell Freedlund, and Samantha Balsiger were present

The notice was posted at the Sherwood Town Hall, the Roadhouse Bar & Grill and at the Sherwood Electrical Substation.

Agenda as follows: call to order, pledge of allegiance, reading and approval of last month's minutes, treasurer's report and town correspondence, Reports from the town officers. - e. Cemetery Expansion Project: Andy C. said the hang up is the moving of the section corner. We are still awaiting finalization by the County. Broken branches at the cemetery have been cleaned up after two extremely windy days. It is recommended that the tree be professionally removed.
- f. Roads: The Clark County Forestry and Parks Department has announced the 50/50 Road Grant for Town Roads running through County Forests. Information will be sent to Andy C. JJ Brush Cutting will be performing brush cutting on the east side of the

town after the 1st of March. Ken S. asked that the Gravel bids go out in April with the opening of the Bids at the May meeting.
