

2025 TOWN OF SHERWOOD

CLARK COUNTY, WISCONSIN

MARCH 15th,2025

The meeting of the Town Board of Sherwood was called to order on Saturday March 15th,2025 at 9:00am at the Sherwood Town Hall, W896 Sherwood Rd, Granton, WI. Supervisor Ken Schwanebeck, Supervisor, Rick Schwanebeck, Treasurer, Bill Rosandick and Clerk, Margaret “Peggi” Schwanebeck were present. Residents: Lowell Freedlund was present.

The notice was posted at the Sherwood Town Hall, the Roadhouse Bar & Grill and at the Sherwood Electrical Substation.

Agenda as follows: call to order, pledge of allegiance, reading and approval of last month’s minutes, treasurer’s report and town correspondence, Reports from the town officers. Continuing Business, Public comment (upon recognition of chairman), Pay bills, set dates for the April 2025 Town Board meeting, Annual Meeting and adjournment.

Supervisor Kenneth Schwanebeck called the meeting to order at 9:00am. The minutes from February 15th, 2025, meeting was read. Rick S. made a motion to accept minutes as read. The motion was seconded by Ken S. The motions carried.

The Treasurer’s report was given. We have \$115519.85 in the bank as of February 28th,2025. The January 31st,2025 was amended with an ending balance of \$301238.81, after a review of the bank statement.

Continuing Business:

- a. Correspondence: Brian Duell the Clark County Highway Commissioner sent an email with the start date of March 11th,2025 for the Spring Weight Restrictions on Clark County Highways.
- b. Roads: Rick S. made a motion to apply for the 50/50 Grant from the Clark County Forestry and Parks Department. It was seconded by Ken S. Motion carried. The request is for 20 loads of gravel on Sherwood Rd west and Ballard Rd west and 10 loads of gravel on Sandhill Ave. These roads have a Logging Truck traffic. JJ Brush Cutting will be performing brush cutting on the east side of the town after the 1st of March. The road signs at the corner of Badger Ave north and Hwy 73 have been stolen, and replacement signs will be ordered. The Stop sign at the corner of Sherwood Rd and Hwy 73 is also gone. Ken used our stop sign for a replacement. Rick S. will contact the Clark County Highway Department for a new sign.
- c. Cemetery Expansion Project: Andy C. has been in contact with Jeanette from Harley Surveying LLC, about the descriptions of the land to be purchased. The Clark County Surveyor stated that the section corner for the section line cannot be changed. The

description of the cemetery includes the discrepancy between the county's section line and the survey of the cemetery. The final descriptions of the 2 properties to be purchased have been sent to the lawyer's office. They will now work with the property owners.

- d. WTA District meeting: Rick S. attended the Saturday March 1st meeting at the Eagles Club in Marshfield WI. The BOR State committee is pushing for all BOR officers to be trained every year.
- e. Annual Meeting: April 15th, 2025 at 6pm. The meeting will be held to postpone the meeting until May 2025.
- f. Next Town Board Meeting: Saturday, April 12th, 2025, at 9:00am.
- g. Election April 1st, 2025: The Town Board of Sherwood is on the ballot. Please vote!
- h. Annual Picnic Date: August 9th, 2025
- i. Checks paid: 5179 to 5196.
- j. A motion by Ken S. and seconded by Rick S. to adjourn. The motion carried.
