The meeting of the Town Board of Sherwood was called to order on Saturday April 12th,2025 at 9:00am at the Sherwood Town Hall, W896 Sherwood Rd, Granton, WI. Supervisor Ken Schwanebeck, Supervisor, Rick Schwanebeck, Treasurer, Bill Rosandick and Clerk, Margaret "Peggi" Schwanebeck were present. Newly elected officials: Samatha Balsiger, and Lowell Freedlund were present.

The notice was posted at the Sherwood Town Hall, the Roadhouse Bar & Grill and at the Sherwood Electrical Substation.

Agenda as follows: call to order, pledge of allegiance, reading and approval of last month's minutes, treasurer's report and town correspondence, Reports from the town officers. Continuing Business, Public comment (upon recognition of chairman), Pay bills, set dates for the May 2025 Town Board meeting, Annual Meeting and adjournment.

Supervisor Kenneth Schwanebeck called the meeting to order at 9:00am. The minutes from March 15th, 2025, meeting was read. Ken S. made a motion to accept minutes as read. The motion was seconded by Rick S. The motions carried.

The Treasurer's report was given. We have \$112905.33 in the bank as of March 31,2025.

Continuing Business:

- A. Oath of Office: newly elected and re-elected officers signed their oaths. Rick Schwanebeck-Supervisor; Lowell Freedlund-Supervisor; Samantha Balsiger-Treasurer; and Margaret Schwanebeck-Clerk. Re-elected chairman Andy Cegielski will sign his Oath at the May 2025 board meeting. We would like to thank Ken Schwanebeck with his many years of service to the Town of Sherwood Board as Supervisor and former Town Chairman. And thank you to Bill Rosandick for stepping in as the interim Treasurer. Bill has helped this community twice now when job positions were unexpectedly vacated.
- B. Election Results: there were 125 voters that voted in the April 1st, 2025, election from the town. That is a 70% turnout!

- E. Roads: **Gravel Bids**: Ken S. made a motion to put out bids for gravel for the town roads. Rick S. seconded the motion. Motion carried. **Brush & Ditch cutting for 2025**: Spring brush cutting on the roads on the east side of the town is on hold due to the spreading of the Oak Wilt. We will have this done after the leaves are off the trees in

the fall. JJ Bruch Cutting will be charging \$75/ hr for mowing and \$90/hr for brush cutting. Ken S. made a motion to hire for 2025 season. Rick S. seconded the motion. Motion carried. **Kafka Dustbusters**: CaCl is \$1.50/gal. and the MgCl is \$1.55/gallon. Ken S. made a motion to purchase a tanker truck load for the roads this year. Rick S. seconded the motion. Motion carried. **Town of Washburn**: Andy spoke to Tony Suda from the Town of Washburn about projects that they want to do on Meridan Rd. Ken S. made a motion to table this until the May 2025 meeting when Andy C. is back. Rick S. seconded the motion. Motion carried. **Grader Maintenance**: the grader is at almost 1000 hours and is due for its maintenance. The cost is \$4000 for this. It will be discussed at the May meeting. McCoy Forestry is a service company. **East Fork Bridge**: a railing support will be repaired this year. **Tree Cutting**: Rick S. cut the leaning trees on Ballard and Sherwood roads. **Blacktop Repair**: Andy C. has a meeting scheduled with American Asphalt to assess the repair cost on Badger Ave. north and south.
