2025 TOWN OF SHERWOOD

JUNE 10th, 2025

The meeting of the Town Board of Sherwood was called to order on Tuesday June 10th,2025 at 6:00pm at the Sherwood Town Hall, W896 Sherwood Rd, Granton, WI. Board members present: Andy Cegielski, Rick Schwanebeck, Lowell Freedlund, Margaret Schwanebeck, and Samantha Balsiger. Jeanette from Harley Surveying.

The notice was posted at the Sherwood Town Hall, the Roadhouse Bar & Grill, the Town of Sherwood website, and at the Sherwood Electrical Substation.

Agenda as follows: call to order, pledge of allegiance, reading and approval of last month's minutes, treasurer's report and town correspondence, Reports from the town officers. Continuing Business, Public comment (upon recognition of chairman), Pay bills, set dates for the July 2025 Town Board meeting.

Chairman Andy Cegielski called the meeting to order at 6:00pm. The minutes from May 13th, 2025, meeting were read. Lowell F. made a motion to accept minutes with corrections. The motion was seconded by Andy C. The motions carried.

The Treasurer's report was given. There is \$106,253.48 in the bank as of May 31st, 2025.

Continuing Business:

- A. Cemetery Expansion Project: Jeanette from Harley Surveying explained the new cemetery plotting. After reviewing the plotting, it was agreed to by the board to sign the paperwork for the new cemetery design. It was signed by Lowell Freedlund, Andy Cegielski and Margaret Schwanebeck. The plotting will be taken to the County Board meeting for approval. Discussion of the ground preparation in the new section was addressed. All Season's Tree Service sent a quote for\$2800.00 for the removal and clean-up of the dead pine tree. Rick S. spoke to Jeff Zawislan from Giant Jeff Tree Cutting and he would do the job for \$2000.00. Lowell F. made a motion to hire Jeff Zawislan pending and contingent on a written quote and proof of insurance. Rick S. seconded the motion. Motion carried. Rick S. made a motion to hire Ken Schwanebeck to till up the ground at \$75.00/hour. Andy seconded the motion. Motion carried. Rick S. will speak to Ken Schwanebeck.
- B. Roads: The new culvert on Ballard east of Hwy Z will be inspected this fall by Clark County. 4330 gallons of calcium chloride were spread on the roads on June 9. JJ Brush Cutting will be cutting the road ditches during the first week of July. Andy C. is working on the road report for WISLR. Basswood Ave was added to the fall brush cutting. Andy C. received a quote from Scott Construction for the repairs on Badger Ave. north and south. Badger north \$18480.00 and Badger south \$24640.00. American Asphalt's

repair quote was a total of \$19,089.00. Andy C. made a motion to accept American Asphalt. RickS. seconded the motion. Motion carried. Lowell F. checked for the fence line on Meridan road dividing Sherwood and Washburn maintenance responsibility.

- C. Building Permits: tabled until annual meeting.
- D. Assessor: contract renewal is tabled until the November meeting.
- E. **Signs**: Samantha B. spoke to the Pittsville School teacher about the school kids making a "Welcome to Sherwood" sign. He said the cost would be around \$900.00.
- F. Next Town Board Meeting: Tuesday, July 8th,2025 at 6:00pm.
- G. Annual Picnic Date: August 9th, 2025
- H. Checks paid: Numbers 5231 to 5247.
- Bullhead Bash: is scheduled for July 12, 2025, at the Sherwood Campground. Rick Schwanebeck oversees acquiring the Temporary Class B beer permit.
- J. A motion by Rick S. to adjourn. Lowell F. seconded the motion. Motion carried.
