

2025 TOWN OF SHERWOOD

CLARK COUNTY, WISCONSIN

SEPTEMBER 9, 2025

The meeting of the Town Board of Sherwood was called to order on Tuesday September 9th, 2025 at 6:00pm at the Sherwood Town Hall, W896 Sherwood Rd, Granton, WI. Board members present: Andy Cegielski, Lowell Freedlund, Rick Schwanebeck, Margaret Schwanebeck, and Samantha Balsiger. Resident: Taylor Gardener. New Beaver Contract person, David Wagner.

The notice was posted at the Sherwood Town Hall, the Town of Sherwood website, Connie's Roadside Bar & Grill, and at the Sherwood Electrical Substation.

Agenda as follows: call to order, pledge of allegiance, reading and approval of last month's minutes, treasurer's report and town correspondence, Reports from the town officers. Continuing Business, Public comment (upon recognition of chairman), Pay bills, set dates for the October 2025 Town Board meeting.

Chairman Andy Cegielski called the meeting to order at 6:00pm. The minutes from August 14th, 2025, meeting were read. Rick S. made a motion to accept minutes as read. The motion was seconded by Lowell F. The motions carried.

The Treasurer's report was given. There is \$103,899.01 in the bank as of August 31st, 2025.

Continuing Business:

- A. **Beaver Contract:** David Wagner was introduced to the board. He asked for \$150.00 for the contract with \$30.00 per beaver caught. Rick S. made a motion to hire David Wagner to remove pesky beavers from the Town of Sherwood for \$150.00 for the year and \$30.00 per beaver caught. It was seconded by Lowell Freedlund. The motion carried. He will remove beavers when called to by the town board, for the safety of our residents.
- B. Resident Taylor Gardener was recognized by the Board. A.) He spoke to the board about the speed of vehicles on Colonial Rd. The board discussed the reduction of the speed to 45 mph for Ballard east, and Colonial road. The clerk stated that she had read that gravel road has a state speed limit of 45 mph. Designated Rustic Roads have a state DOT speed limit of 45mph. The town Board will take up the change of the speed limits for these two roads at the October meeting. b.) He requested placing of "Slow Children Playing" signs on Colonial. The board approved the signs to be placed on Colonial and Ballard east roads. Rick S. made a motion for this sign to be placed on Ballard east and Colonial road. Lowell F. seconded the motion. The motion passed.
- C. **Roads & Culverts:** a.) JJ Brush Cutting will make 2 passes mowing the ditches in October. B.) JJ Brush Cutting will cut brush along Sherwood East, Colonial north and

south, Ballard east, Basswood and Anderson Rds, in late October. The cost is limited to \$5000.00.

- D. **Cemetery Expansion Project:** Lowell F. stated that the cemetery work has been completed for this year. Ken Schwanebeck tilled up the new addition and the old south fence line was mowed. Money for the driveway into the new addition will be put into the 2026 budget.
- E. **GAFA fire bill:** Andy C. spoke to Tasha Appel about their reimbursing the town for the fire bill.
- F. **Cooper Gas:** a.) Andy C. spoke with Steve from Cooper Oil and Propane, the repair work on the tank should be this week. b.) Andy C. made a motion to contract with Cooper Oil and Propane to pre-pay for 500 gallons of propane for this winter (2025-2026). Rick S. seconded the motion. The motion carried.
- G. **Next Meeting:** Tuesday, October 14th, 2025 at 6:00pm.
- H. **Checks approved:** 5283 to 5297 were read.
- I. **Adjournment:** Lowell F. made a motion to adjourn the meeting. It was seconded by Rick S. The motion carried.
