

# 2025 TOWN OF SHERWOOD

## CLARK COUNTY, WISCONSIN

**November 8th, 2025**

The meeting of the Town Board of Sherwood was called to order on Saturday November 8th, 2025 at 10:25am at the Sherwood Town Hall, W896 Sherwood Rd, Granton, WI. Board members present: Andy Cegielski, Lowell Freedlund, Rick Schwanebeck, Margaret Schwanebeck, and Samantha Balsiger.

The notice was posted at the Sherwood Town Hall, the Town of Sherwood website, Connie's Roadside Bar & Grill, and at the Sherwood Electrical Substation.

Agenda as follows: call to order, pledge of allegiance, reading and approval of last month's minutes, treasurer's report and town correspondence, Reports from the town officers. Continuing Business, Public comment (upon recognition of chairman), Pay bills, set dates for the December 2025 Town Board meeting.

Chairman Andy Cegielski called the meeting to order at 10:25 am following the Budget and Levy meetings. The minutes from October 14th, 2025, meeting were read. Lowell F. made a motion to accept minutes with the noted corrections. The motion was seconded by Rick S. The motion carried.

The Treasurer's report was given. There is \$53147.10 in the bank as of October 31st, 2025.

### **Continuing Business:**

- A. **Roads & Culverts:** a.) JJ Brushing cutting mowed the ditches and did a light brush cutting. Andy C. will call to have them do the fall brush cutting on several roads. b.) The poles for the speed limit and child present signs will be arriving the week of 11/10/2025 and will be installed. c.) Opelt's Sand & Gravel sent their contract for sanding and salting of the roads this winter 2025-2026. The costs are the same as 2024-2025 winter. Andy C. made a motion to accept the contract. Rick S. seconded the motion. The motion carried.
- B. **Cemetery:** It was brought to Lowell F.'s attention that the remains of Richard Jacobson's parents were buried on the wrong side of the headstone. They are on someone else's plot. Lowell will speak to Mr. Jacobson about reburial of the remains correctly.
- C. **Assessor Contract:** Chimney Rock Appraisal sent us a one-year maintenance contract for 2026 for \$5100.00. Rick S. made a motion to accept the contract. It was seconded by Andy C. the motion carried.
- D. **2026 Budget:** Andy C. made a motion to accept the 2026 Budget. It was seconded by Lowell F. The motion carried.

- E. **2025 Levy:** Andy C. made a motion to accept the 2026 Levy. It was seconded by Lowell F. The motion carried.
- F. Lowell F. made a motion to remove the picture of the former town clerk from the website. Rick S. seconded the motion. The motion carried.
- G. **Next Meeting:** Tuesday, December 9th, 2025 starting at 6:00pm.
- H. **Checks approved:** 5318 to 5331 were read.
- I. **Adjournment:** Lowell F. made a motion to adjourn the meeting. It was seconded by Andy C. The motion carried.
