The Annual Meeting of the Electors of the Town of Sherwood, Clark County, WI was called to order on May 1, 2026 at 06:00pm at the Sherwood Town Hall. The Following Electors were present — Chairman- Andy Cegielski, Supervisor- Lowell Freedlund, Supervisor- Rick Schwanebeck, Clerk- Margaret Schwanebeck, Treasurer-Samantha Balsiger, Resident- Robert Fluegel, Granton Area First Responders-Pat Wolf and Janell Walters.

The meeting was called to order at 06:00 PM. The Pledge of Allegiance was recited. After the minutes of the 2025 Annual Meeting were read, a motion by Rick Schwanebeck to accept the minutes as read. It was seconded by Lowell Freedlund to accept the minutes as read. Motion approved by all 6 electors.

Pat Wolf gave a report on the total number (168) of calls in 2025. 20 calls in Sherwood. Janell Walters gave the breakdown of the income and expenses. There are 18 volunteers that staff the GAFR. We would like to thank all the GAFR for their service to our community. Rick Schwanebeck made a motion to donate \$3000 to the Granton Area First Responders. It was seconded by Robert Fluegel. Motion approved by all 6 electors.

The Annual Financial Report 2025 was reviewed. A motion was made to accept the report as presented by Rick Schwanebeck and seconded by Samantha Balsiger. Motion approved by all 6 Electors.

Cemetery: Lowell Freedlund gave an update on the work done at the cemetery. There are only 26 sites left in the old section. This year the driveway and landscaping will be done on the new addition. The Town Board will ask for bids for the landscaping.

Margaret Schwanebeck made a motion to increase the Clerk's salary to \$9600/year. It was seconded by Rick Schwanebeck. Motion carried by all 6 electors. This increase will take place after the election in 2027. The clerk's position is an elected position. Margaret Schwanebeck said that she will not be up for re-election in 2027.

Margaret Schwanebeck made a motion to raise the treasurer's salary to \$600/year. It was seconded by Rick Schwanebeck. Motion carried by all 6 electors. This increase will take place after the election in 2027. The treasurer's position is an elected position.

Rick Schwanebeck made a motion to donate \$100 to the Clark County Humane Society and it was seconded by Samantha Balsiger. Motion carried by all 6 electors.

Margaret Schwanebeck spoke about the need to have building permits. This way the town and assessor know what is being built in the town. The board will address this issue sometime this year.

Andy Cegielski said that the Road Dust control will be put on the roads soon. The town received money from Clark County for the 50/50 grant.

The 2027 Annual meeting will be held on the 3<sup>rd</sup> Tuesday in April.

Andy Cegielski made a motion to adjourn the meeting, and it was seconded by Rick Schwanebeck. Motion carried by all 6 electors.
