

# 2026 TOWN OF SHERWOOD

## CLARK COUNTY, WISCONSIN

**May 12, 2026**

The meeting of the Town Board of Sherwood was called to order on Tuesday, May 12th, 2026 at 06:00 PM at the Sherwood Town Hall, W896 Sherwood Rd, Granton, WI. Board members present: Andy Cegielski, Lowell Freedlund, Rick Schwanebeck, Margaret Schwanebeck, and Samantha Balsiger.

The notice was posted at the Sherwood Town Hall, the Town of Sherwood website, Connie's Roadhouse Bar & Grill, and at the Sherwood Electrical Substation.

Agenda as follows: call to order, pledge of allegiance, reading and approval of last month's minutes, treasurer's report and town correspondence, Reports from the town officers. Continuing Business, Public comment (upon recognition of chairman), Pay bills, set date for the June 2026 Town Board meeting.

Chairman Andy Cegielski called the meeting to order at 06:00 PM. The minutes from April 12th, 2026, meeting were read. Rick S. made a motion to accept minutes as read. The motion was seconded by Lowell F. The motion carried.

The Treasurer's report was given. There is \$137,116.07 in the bank as of April 30th, 2026.

### **Continuing Business:**

- A. **Gravel Bids:** Bugar Trucking, Loyal, WI= bid \$15.25 per yard for ¾ inch, delivered. Haas Trucking, Thorp, WI=bid \$16.10 per yard, delivered. Rick S. made a motion to accept Bugar Trucking 's bid. Lowell F. seconded the motion. The motion carried.
- B. **Roads & Culverts:** a.) **Dust Control Kafka Dust Busters** quoted \$1.55 for MgCl and \$1.60 for CaCl. Andy C. made a motion to purchase approximately 4900 gallons of MgCl. Rick S. seconded the motion. The motion carried. b.) **50/50 Grant** from Clark County Forestry Dept: the town will receive \$3900 for gravel work on Sherwood Road. c.) **JJ Brush Cutting:** Lowell F. made a motion to have 2 mowing passes on the town ditches in July. Rick S. seconded the motion. The motion carried. d.) **Culvert replacement:** culvert on Basswood needs replacement.
- C. **Fire bill:** a.) The clerk received a call from Neil Pfeiffer III's mother stating that they are working on the paperwork together to submit to the insurance company, for the GAFA fire bill for Neil Pfeiffer accident in November 2025.
- D. **Dog Licenses:** 4 notices were sent to dog owners; all owners paid for their dogs licenses.
- E. **Beaver Contract:** not due for renewal until September 2026.
- F. **Building Inspector:** Andy C. will contact Dan Hansen about his information.
